# Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault

New Zealand Study Trip 14 – 17 May 2017

## **Purpose**

The trip encompassed children protection and housing reforms that are being implemented in New Zealand. The trip provided an opportunity to meet with and exchange ideas with practice leaders from New Zealand and understand their experience of the early challenges they have faced in implementing a reformed commissioning system. This will assist in ensuring that NSW continues to be a world leader in service provision that breaks disadvantage.

New Zealand through *Investing in Children* and NSW with *Their Futures Matter* have both announced reforms which call for long-term transformation to improving outcomes for vulnerable children and families. Both reports provided detail on the significant challenges facing the current systems, including rising costs and poor outcomes, especially for Indigenous populations. They also emphasised the need to coordinate the disparate effort across agencies and better target services for the most vulnerable in order to influence the drivers of demand

The study trip provided an opportunity to learn firsthand how New Zealand is transforming their care and protection systems. It was an opportunity to talk directly to staff across government agencies and organisations who are implementing this new system.

#### **Description**

The delegation met with key leaders from the *Ministry for Vulnerable Children*, *Oranga Tamariki*, which commenced operations on 1 April 2017. The new Ministry focuses on the following:

- A focus on prevention by investing early in children and families
- Intensive intervention when concerns escalate
- Care support that enables children to develop life-long relationships with caregiving families
- Youth justice services that focus on preventing reoffending and helping children and young people live crime free lives
- Investment in transition support to enable young people to make a positive transition from care or youth justice.

The Ministry facilitates New Zealand's "Investing in Children" reforms by delivering:

- A 'whole of sector', child-centred approach to the way that Government works with vulnerable children and young people.
- A single point of accountability for ensuring vulnerable children and their families to receive the services they need.
- A focus on prevention as a core area of focus.

### **Key Outcomes/Benefits of travel for NSW**

The study trip provided an opportunity to strengthen connections with key leaders in New Zealand and to learn about the early design and implementation challenges of a commissioning system.

The experience provided an opportunity for critical reflection on how NSW could enhance reforms through a better understanding of the new operating model that has been implemented by the *Ministry for Vulnerable Children*, *Oranga Tamariki*.

The New Zealand reform focuses on harm and trauma prevention and early intervention.

Similarities with New Zealand reforms to NSW include:

- The adoption of an investment approach, using actuarial valuations and evidence of what works to identify the best way of targeting early interventions, to ensure vulnerable children receive the care and support they need.
- A stronger focus and targets aimed at reducing the over-representation of Indigenous people (Aboriginal or Māori) in the system.
- The establishment of a single point of accountability (through the creation of a new Ministry in New Zealand, and a single commissioning entity in NSW), with significantly expanded mandate, funding and governance.
- Direct purchasing and commissioning of services such as health, education, with funding following the child.

In conclusion, the trip to New Zealand provided an opportunity to learn about the design and implementation challenges of a commissioning based system so that New South Wales is able to avoid some of the early mistakes made by New Zealand, and to understand how they intend to use data to test and monitor the new system and its outcomes for the most vulnerable.
