Declaration

- I/we authorise DCJ to confirm information provided by me with any third party and for any such third party to
 provide DCJ any relevant documentation or information sought by DCJ when determining or supporting this
 authority.
- I/we authorise Centrelink to take out of my/our Centrelink payment, amounts in respect of my/our agreement with DCJ and pay the amounts stated above directly to DCJ.
- I/we understand that if my/our rent, or other amounts change, DCJ will tell Centrelink and the new amount will be taken out of my/our Centrelink payment from the next available pay date.
- Where my/our rental or water account has an outstanding debt balance of less than one hundred (\$100) dollars, I/we agree to an extra amount of up to ten (\$10) each fortnight in each account to be taken from my/our Centrelink payment until the balance is cleared.
- I/we agree in the event of my/our rental bond account falling into arrears, I authorise DCJ to increase my fortnightly payment by up to ten dollars (\$10) until the arrears are fully paid.
- I/we understand that it is my/our choice to have the above amounts deducted from my/our Centrelink payment and that I/we can withdraw from the scheme at any time.
- I/we agree that if a person other than the tenant contributes to payments that are the tenant's legal responsibility, no rights or claims against DCJ are conferred on that person.
- I/we agree that the rights and obligations of DCJ to any occupier of the property are not diminished in any way by the fact that current payments are received from Centrelink.
